Wick Sports Pavilion Update

Following the decision by the Vale Council that the Sports Pavilion is surplus to their requirements, it is still intended that the Community Council will take a 25-year lease on the Pavilion. However, due to the pandemic, no date has yet been set for the signing of the lease. We hope it will take place early in 2021

Since the last newsletter there have been several changes in the rules for the use of community buildings. Currently, due to Covid restrictions, the Pavilion is available for hire to organisations, but there are limits on the numbers of people permitted to use it and the purposes for which it can be used.

External Audit

Wick Community Council have been informed by the External Auditor that accounts and statements submitted for 2019/20 cannot currently be approved, until accounts for 2017/18 and 2018/19 are submitted. The Accounting Statement for 2019/20 can be viewed on the website www.wickcc.wales

Councillor Hawkins, the Clerk and Proper Officer, has apologised for not submitting the accounts for 2017/18 and 2018/19, attributing increased workload with regard to the Sports Pavilion as the main reason. He has also apologised for not informing councillors.

In May of last year, the Community Council appointed Councillor Murphy as Responsible Finance Officer (RFO). He will now prepare the accounts for previous years, and they will be submitted to Council and External Auditor for approval in January 2021.

Councillor Ambrose, the Chair of the Community Council, would like to report that the RFO has carried out a pre-audit of accounts and can confirm that all receipts and payments agree with bank balances.

The 2017/18 and 2018/19 accounts and all documents will be made available for public inspection for 20 working days in early 2021.
