We have previously agreed to appoint CJHC as our solicitor, the cost of finalising the lease is expected to be around £2500.</p> <p>In respect of the sub lease with the cricket club our solicitor advised that the cost for the lease is estimated at £1000 to £1500. If we want her to do the Heads of Terms that would be an additional £500.
